

REQUIRED BY LAW — CMA FUNERALS MARKET INVESTIGATION ORDER 2021

Standardised Price List

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL (funeral director's charges only)		£3,400
<i>This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.</i>		
Taking care of all necessary legal and administrative arrangements		£1,150
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care		£450
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's branch premises		£350
Providing a suitable coffin – this will be made from wood veneer		£400
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)		£300
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle		£750

UNATTENDED FUNERAL

<i>This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.</i>		
Burial (funeral director's charges only)		£995
Cremation (funeral director's charges plus the cremation fee) ²		£1,875

FEES YOU MUST PAY

For an Attended or Unattended burial funeral, the burial fee. ¹ In this local area, the typical cost of the burial fee for local residents is: For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.	£2,690– £10,030
For an Attended cremation funeral, the cremation fee. ² In this local area, the typical cost of a cremation for local residents is:	£845– £1,435

ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:	
Additional mileage (price per mile)	£2
Additional transfers of the deceased person's body (e.g. to their home, to a place of worship etc.) (price per transfer)	Prices on request
Collection and delivery of ashes	£50
Embalming	£200
Alternative coffins and caskets (a full range is available to view)	Prices on request
Funeral officiant (e.g. celebrant, minister of religion etc.)	from £250
Services supplied outside of normal office hours	Prices on request

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

¹ The burial fee is set by the cemetery or burial ground, not by the funeral director. The range shown is based on Kemnal Park (2026): a burial service at £895 and interment at £1,795. The upper figure adds a new traditional grave plot and the grave permit fee. Other cemeteries in the area charge different amounts.
² The cremation fee is set by the crematorium, not by the funeral director. The range shown reflects published 2026 fees for attended services at Bluebell, Beckenham, Croydon and Kemnal Park. Early morning and shorter services cost less than the standard hour.
